### **Residency Descriptions:**

#### Advocate Christ Medical Center Oak Lawn, Illinois

Advocate Christ Medical Center is a 695-bed teaching, research and tertiary care hospital, Level I trauma center, Level III perinatal center, and one of the largest hospitals in the Chicago area. As part of ACMC, Advocate Children's Hospital is one of the most comprehensive providers of pediatric services in the state. The PGY-1 Residency at (ACMC) is a compressive twelve-month program designed to professionally cultivate expert clinicians who possess a strong desire to practice independently and excel in clinical service. The program emphasizes clinical practice and includes rotations in anticoagulation, drug information, emergency medicine, general medicine, infectious disease, medical intensive care, pediatrics, practice management, and surgical intensive care. Elective rotations are available in other clinical and administrative areas. The goal of the PGY-2 Residency in Emergency Medicine at ACMC is to professionally prepare a pharmacist for successful clinical practice in an emergency department. This one year residency program is designed to provide advanced training in all aspects of emergency care, including toxicology, critical care, and emergency preparedness. The pharmacy resident will demonstrate an understanding of the pathophysiology, diagnosis, and management of disease states common within the ED and will optimize drug therapy through the development of evidence-based treatment plans. The resident will be required to participate in research, provide education to pharmacy and ED staff, and serve as a co-preceptor for pharmacy students and general practice residents.

### Advocate Lutheran General Hospital, Park Ridge, IL

Advocate Lutheran General Hospital is a 640-bed tertiary care, academic and research hospital, and the only Level I trauma center in the northwest suburban region of Chicago. It was founded in Chicago in 1897, and celebrated its 50th year at its Park Ridge location in 2009. Advocate Lutheran General Children's Hospital is one of the most comprehensive providers of pediatric care in the state. It is the only children's hospital in the north and northwest suburbs of Chicago, a Level III perinatal center (the highest designation) and a Pediatric Critical Care Center. In addition to its medical/surgical services, the hospital also provides CCU, dialysis, adult and adolescent psychiatry, obstetrics/gynecology, pediatric and neonatal ICU, trauma, cancer care, and physical medicine specialty services. Lutheran General offers medical residencies in eight specialty areas. The pharmacy provides clinical and hospital clerkship rotations to pharmacy students from the University of Illinois College of Pharmacy and Chicago College of Pharmacy among others. The program is flexible enough to provide the resident with an opportunity to concentrate on a practice area of special interest. The program goes beyond content knowledge, to develop cognitive and professional skills of a professional pharmacist.

PGY1 Pharmacy Residency Program: This 12-month post-graduate program offers the pharmacy resident comprehensive training in acute care pharmacy practice. After completing this program, the resident will be prepared to seek a clinical pharmacist position in an acute care setting or a PGY2 specialty resident position. PGY1 Community Pharmacy Residency Program: This 12-month post-graduate program offers the pharmacy resident comprehensive training in a variety of community/ambulatory settings. During the program, the resident will staff

in both retail and ambulatory settings. After completing this program, the resident will be prepared to seek a clinical pharmacist position in a community or ambulatory setting or a PGY2 specialty resident position. PGY1/PGY2 Health-System Pharmacy Administration Program: This 24-month post-graduate program prepares the resident to assume high-level managerial, supervisory and leadership responsibilities. It is a teaching hospital, providing a full range of patient care services, with state-of-the-art technology as well as education and research. Comprehensive health care is provided through primary and tertiary care in the areas of medicine, surgery, psychiatry, physical medicine and rehabilitation, neurology, oncology, dentistry, and geriatrics. Clinical pharmacy services at Jesse Brown VA Medical Center are provided by pharmacists employed by the VA and the University of Illinois College of Pharmacy. Decentralized clinical pharmacists provide pharmaceutical care to the inpatient population. Ambulatory care involvement includes pharmacy-managed clinics, as well as participation in interdisciplinary primary care clinics with physicians, nurses and dietitians. Jesse Brown VA Medical Center has active affiliations with the Northwestern University Medical School and the University of Illinois at Chicago Colleges of Medicine and Pharmacy. Over 900 University residents, interns, and students are trained at JBVAMC each year. The pharmacy service trains over 120 students from the University of Illinois yearly. The Jesse Brown VA Medical Center PGY-1 Pharmacy Residency Program targets core areas of pharmacy practice, with an emphasis on ambulatory care, and fosters an integrated inpatient/outpatient team approach to patient care. The program accommodates for individual experience and specific areas of interest. The resident is exposed to quality assurance and medication use evaluation activities, and participates in formulary management through the Pharmacy and Therapeutics Committee. The resident will participate in the training of Doctor of Pharmacy candidates and will have the opportunity to earn a teaching certificate from the University of Illinois College of Pharmacy. Each resident conducts a research project and presents the results at the Great Lakes **Pharmacy Resident Conference.** 

# Loyola University Medical Center Maywood, Illinois

Loyola University Health System, which is a member of Trinity Health, is an 801-bed multi-campus organization which includes the Loyola University Medical Center campus in Maywood (570 beds including the Cardinal Bernadin Cancer Center, the Ronald McDonald Children's Hospital of Loyola, the Burn/Trauma Center, and the Center for Heart & Vascular Medicine) and the Gottlieb Memorial Hospital campus in Melrose Park. Loyola offers a wide range of medical, surgical and obstetrical services including many specialty services. Loyola University Medical Center is the only academic teaching hospital in the western suburbs of Chicago and is also a large referral center for this area. Loyola is an accredited Level I Trauma Center, a Burn Center, and is served by an aeromedical program that transports patients from up to 150 miles away to Loyola. Specialty services include transplantation, cardiovascular surgery, oncology, women's health, primary care, and pediatrics among many others. Loyola University Medical Center houses nine discrete critical care units (neurological, medical, cardiovascular, cardiac, surgical/trauma, bone marrow transplant, burn, pediatric, and neonatal).Loyola University Health System offers a one-year post-graduate year one (PGY1) pharmacy practice residency. The program is designed to offer a wide variety of clinical practice experiences in critical care medicine and surgery, general medicine, cardiology, pediatrics, transplantation, and infectious diseases. Graduates of this program will be well-rounded practitioners with the skills to practice in a variety of care settings. Graduates will possess the knowledge and critical thinking skills to function as members of a multidisciplinary team to provide pharmaceutical care to patients with a wide variety of disease states. Pharmacy residents are provided the opportunity to accelerate their growth beyond entry-level professional competence in patient-centered care and in pharmacy operational services, and to further the development of leadership skills that can be applied in any position and in any practice setting. Pharmacy residents acquire knowledge required for skillful problemsolving, refine their problem-solving strategies, strengthen their professional values and attitudes, and advance the growth of their clinical judgment. The core pharmacy residency experiences include inpatient care rotations in general medicine, pediatrics, critical care (2

rotations), infectious diseases, cardiology, administration, operations (longitudinal), and research. The pharmacy resident will complete 12 four-week rotations consisting of 9 required rotations and 3 electives.

The purpose of the MWU-CCP PGY2 Residency Programs is to transition a PGY1 residency graduate from a general practitioner to a specialist in a select therapeutic area. The College primarily partners with Northwestern Memorial Hospital and Rush University Medical Center to deliver its PGY2 residencies in Critical Care and Infectious Diseases. These programs are designed to develop expertise in the specific therapeutic area and to prepare residents to function independently in patient care settings and as pharmacy faculty.

The PGY2 Ambulatory Care Residency is new and will be recruiting for its first residents to begin in July 2015. The College has already submitted its application for pre-candidate status with ASHP and will pursue full accreditation of the program. The two primary practice sites are Advocate Southeast Clinic in Chicago and the DuPage Medical Group Breakthrough Care Center in Lombard, IL. Residents in this program will build on their skills from their PGY1 residency and develop into independent ambulatory care clinicians who will be able to manage a variety of chronic diseases and initiate new services in the ambulatory care setting.

Infectious Diseases Pharmacotherapy Fellowship (2 years)

The fellowship position is a two year post-doctoral program with a focus on translational research. PGY1 Pharmacy Residency (17 positions): NorthShore University Health System has four hospitals including Evanston, Glenbrook, Highland Park, and Skokie Hospitals. We have 17 pharmacy practice residents divided among the 4 sites and offer a comprehensive program with both clinical and management exposure. Core rotations include general adult medicine, critical care, antimicrobial stewardship, and pharmacy administration. Elective rotations are available in many areas, including cardiology, neonatology, oncology/hematology, women's health, pharmacy informatics, surgery, infectious diseases, and emergency medicine. Residents participate in multidisciplinary committees and are involved with precepting pharmacy students. We also offer a teaching certificate program through an affiliation with Rosalind Franklin University College of Pharmacy. Residents receive ACLS training and attend codes. Practice management skills are developed through completion of projects related to quality improvement, financial management, human resources, medication safety, drug use policy, drug distribution and customer service.

PGY2 Oncology Pharmacy Residency (1 position): The PGY-2 Oncology Pharmacy Residency program at NorthShore University Health System is a comprehensive specialty pharmacy program that exposes the resident to all areas of cancer patient care; inpatient, outpatient, hospice, home care, investigational studies/research, etc. This program provides residents with opportunities to conceptualize, integrate, and transform accumulated experiences and knowledge into improved patient outcomes. It instills a philosophy of practice that embraces the concept that pharmacists must be responsible and accountable for pursuing optimal drug therapy outcomes. It is designed to give one an opportunity to learn the various aspects of the oncology pharmacist role. Under the supervision of oncology pharmacists, the resident will learn in depth about each cancer and its corresponding management by attending clinic with the physicians/nurses and working alongside other multi-disciplinary healthcare professionals.

PGY1 Community Pharmacy Residency (2 positions): NorthShore University Health System operates outpatient pharmacies in its hospitals (Evanston, Glenbrook, Highland Park, and Skokie Hospitals). All locations are staffed by community pharmacists whose goal is to advance pharmaceutical care by: educating healthcare professionals and students, ensuring appropriate drug therapy outcomes, emphasizing patient education, and influencing drug-therapy decisions. The community pharmacy residency program is designed to develop a resident's ability to implement and provide advanced, high quality pharmaceutical care and patient education in a community pharmacy setting. In addition, the resident will establish collaborative working relationships with community healthcare providers and develop the professional and leadership skills necessary for advancing pharmacy practice.

The Regulatory Pharmaceutical Fellowship specializing in drug information is a two-year, learning based program designed to train the selected candidate on the medical and regulatory aspects of drug information dissemination. The program serves to maintain and enhance a scientific link among the Food and Drug Administration (FDA), academia, and the pharmaceutical industry. The program also provides an opportunity for the fellow to develop an understanding of the processes of the FDA and pharmaceutical industry in the delivery of drug information and the regulatory oversight of drug information practices. The fellowship gives participants the unique opportunity to experience careers in the areas of government, academia and industry, thus, qualifying graduates to pursue career opportunities in each respective area. The fellowship is a two-year program consisting of a 9-month rotation with FDA's Center for Drug Evaluation and Research (Silver Spring, MD); a 6-month rotation with Purdue University College of Pharmacy (Indianapolis, IN); and a 9-month rotation at Eli Lilly & Company (Indianapolis, IN). Fellowship - Drug Information *Purdue University, Indiana University (IU) Health, and Wishard-Eskenazi Health - Indianapolis, IN* 

The 6-month academic drug information portion of the Regulatory Pharmaceutical Fellowship will provide the fellow with exposure to academia and the different functions and responsibilities of institutional-based drug information centers. The program offers experience with the provision of drug information including formulary management, adverse drug event reporting, medication safety, and drug-use policy in conjunction with IU Health and Wishard-Eskenazi Health. In addition, the fellow gains significant experience in academia, providing didactic and experiential training to Purdue University student pharmacists.
