# Where Do You Fit in Illinois' Most Prestigious Hospitals and Health-Systems?

The Reverse Exhibit is exactly what the name suggests: a reversal of the traditional tradeshow format. Hospital pharmacy decision makers (pharmacy directors, clinical managers, drug information specialists, and buyers) will host exhibit booths while vendors walk the floor.

#### **How It Works**

In practice, the Reverse Exhibit concept is very similar to speed dating. Suppliers, vendors, and manufacturers, will have up to 5 minutes of one-on-one time with a hospital pharmacy decision maker before moving to the next pharmacy decision maker of their choice.

Five minutes should be an ample amount of time for a vendor to identify a viable business opportunity, and also for a hospital pharmacy decision maker to recognize whether the product or solution will meet their needs. If you feel you need more time, you have the opportunity to finish your conversation during the Annual Meeting Exhibit Program.

During the Reverse Exhibit, each hospital pharmacy or health-system will have an ID sign on their table -- clearly marking their facility, city and state, their name, and job title. Maps will be available to facilitate easy navigation.
