LEGISLATIVE AND REGULATORY

UPDATE- The spring session of the Illinois General Assembly is still on hold but we've heard that some activity is in the works in the near future. The reason being is that a budget has to be approved before the end of May or a supermajority will be required to pass it after that. While both chambers host a super-majority of democrats and we have a democratic Governor, there's no guarantees so our guess is that the General Assembly will try to get this job done soon. The legislature also has several Sunset renewals before them several Sunset renewals before them (professional licensing Acts that will expire if not extended) so those will take the next level of priority after the budget. While there are a variety of pharmacy and health care bills waiting in the wings, we believe that those bills will have to wait until next year. Although rumors also abound that we could see an expanded Veto Session in the fall to address some of the the fall to address some of the carryover bills. After all, it will be a lame-duck session after the elections in November. These are our (ICHP staff and lobbyists)

best guesses for the last part of the Spring Session, but they are guesses based on discussions and conjecture. Stay tuned to your e-mails and ICHP's social media platforms just to make sure.
