Why have a Position Statement?

- **ICHP's Mission Statement:** Advancing patient care by promoting excellence in pharmacy practice through education, collaboration, advocacy, and leadership.
- **ICHP's Vision Statement**
 - **Serve** as a premier source of education for pharmacy professionals.
 - **Embody** the diversity of pharmacy professionals.
 - **Inspire** collaborative and innovative pharmacy practice.
 - **Empower** pharmacy professionals to improve health equity and outcomes.
 - **Lead** pharmacy advocacy efforts and be recognized as a voice for the profession.

What is a Position Statement?



The Illinois Council of Health-System Pharmacists (ICHP) develops position statements on pharmacy practice and health care policy.



Position statements are intended to guide the practice of pharmacy by its members and clearly express to patients and decision makers the viewpoint of ICHP on important issues affecting the health of patients and their families in Illinois.



ICHP frequently endorses ASHP Position Statements, but there are times when we may need to make a separate statement.

Local/State laws may differ

Practice types, patient access, etc. may make a distinct statement necessary

The life cycle of a position statement in ICHP

Topics for position statements are identified and approved by the ICHP Executive Committee (based on current topics, member recommendation, other need). The topic is then assigned to the appropriate ICHP division(s).

The Position Statement is drafted utilizing appropriate references and sent to the Board for first approval and potential edits.

The Division of Professional Affairs reviews the Board edits and incorporates them into the Position Statement as appropriate. The Position Statement goes back to the Board.

The ICHP Board of Directors gives final approval before a Position Statement is posted on the ICHP website.

The Division of Professional Affairs is responsible for regular periodic review and updating of all Position Statements. Each update goes back through the above approval process.

ICHP Position Statement - Continuing Professional Development

The Illinois Council of Health-System Pharmacists (ICHP) recognizes pharmacy as a healthcare profession. Pharmacists and pharmacy technicians are obligated to maintain their professional competence by keeping their knowledge and skill set current. With the everchanging world of health care delivery and increasing demands of patients, pharmacists and pharmacy technicians must commit to maintaining professional competence through lifelong learning or continuing professional development.

According to Accreditation Council for Pharmacy Education (ACPE), Continuing Professional Development is a "self-directed, ongoing, systematic and outcomes-focused approach to lifelong learning that is applied into practice. It involves the process of active participation in formal and informal learning activities that assist in developing and maintaining competence, enhancing professional practice, and supporting achievement of career goals"¹

ICHP recognizes that pharmacists and pharmacy technicians have an obligation to maintain and enhance their competence through continuing professional development and continuing pharmacy education which can be achieved through a myriad of means. ICHP encourages pharmacists and pharmacy technicians to develop and maintain skills necessary in their current roles as well as those that develop over time.

ICHP supports Pharmacy Professionals in maintaining professional competence through lifelong learning, continuing professional development, and attainment of advanced credentials.

01

Lifelong Learning

Ongoing development throughout one's career.

02

Continuing Professional Development

Self-directed, ongoing, outcomes-focused learning.

03

Advanced Credentials

Specialty certifications and credentials that support professional growth.

It doesn't replace the original statements — it brings them together under one broader vision.

What Changed?

THE EVOLUTION

PREVIOUSLY	NEW UNIFIED POSITION
Two separate statements	One unified statement
Pharmacists & technicians explicitly named	"Pharmacy Professionals"
Maintaining competence	Maintaining competence and advancing practice
CPD and CPE	CPD + experiential learning + collaboration
Credentials as a separate focus	Credentials integrated into lifelong learning
Focus on individual responsibility	Encourages health-system support

Professional development is both an individual responsibility and something health-systems can help enable.

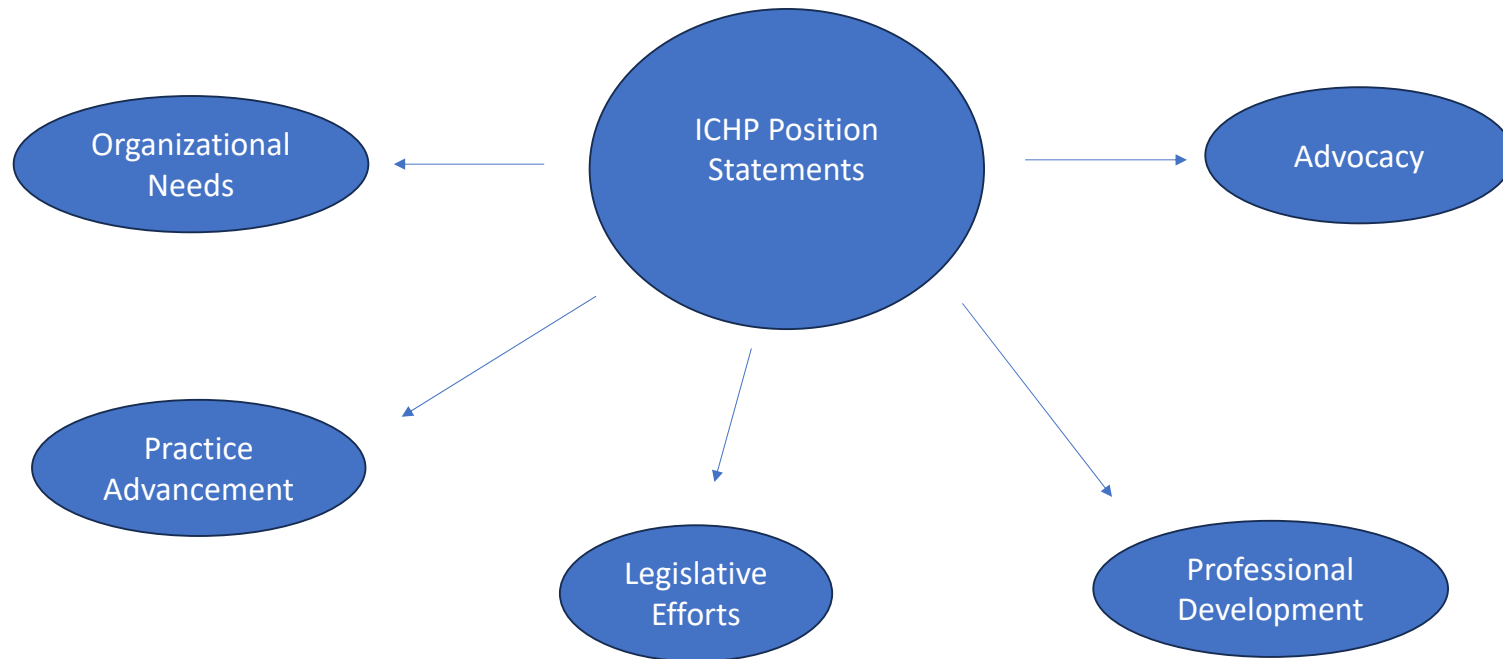

PUTTING THEM TO WORK

How Members Can Use Position Statements

1 Individual (Pharmacist/Technician)

- Strengthen presentations/publications
- Support proposed initiatives (e.g., new programs, certification)
- Quality assurance tool

2 Organization/Leadership

- Build policies
- Support proposed initiatives
- Demonstrate alignment with professional standards

The same statement works at the bedside and in the boardroom.

ICHP Position Statement - Intermediate and OTC Category of Drug Products

The Illinois Council of Health-System Pharmacists (ICHP) supports the switch of drugs from legend status to over the counter (OTC) status when the drug can be used by consumers safely and effectively to treat select medical conditions that can be self-diagnosed and managed without medical supervision.

ICHP recognizes the trend toward greater consumer participation in their healthcare and that having greater access to some medications facilitates self-care.

ICHP supports the development of an intermediate category of non-prescription drugs that would be available from pharmacists. Pharmacists would provide these drugs to patients along with appropriate clinical assessment, monitoring and professional consultation. Examples include, but not limited to, of such drugs include statins, oseltamivir, oral contraceptives injectable epinephrine to treat anaphylaxis, inhaled corticosteroids, leukotriene modifiers, inhaled beta2 agonists for asthma, select therapies for osteoporosis and hypertension, and vaccines.

The Intermediate Category of Drug Products has also been referred to as "behind-the-counter drugs", "pharmacist-only drugs".
