- IL Pharmacy Practice Acts. **Megan.** The Tribune article made legislative day an uphill battle. Pharmacy Practice Act to be renewed, but some of the more progressive changes may be more of a challenge. ICHP representatives met with pro pharmacy legislators regarding contraception prescribing, Mary Flower's bill lack of ICHP IPhA input incorporation. Megan will report back on specific scope of practice language updates from the Gov't Affairs Division for ACN review. Proposal for ACN to review this language and/or create a ICHP policy statement based on our experience and research into ambulatory practice across the state.
- Am Care CE for ICHP - **Chris, Maryann, Tanmayi.** Trish emailed Mary Ann this morning regarding Annual meeting in September. Working through identifying topics, speakers. Wanted to bounce off our group when it comes to ambulatory representation. Thursday morning – Antimicrobial Stewardship – anybody doing this in ambulatory settings? Pharmacist and technician representatives practicing at top of license. Management session – no speakers – cost savings initiatives, medication safety, and oversight of medication use in the clinic. Pain management and stroke management for clinical. Transitions in care. Any ambulatory resident to do a 20 minute pearl of their research? Track and trace, ADT, and informatics pearls.
