AM CARE TASK FORCE DISCUSSION

- Christie has a chronic care clinic including heart failure, diabetes, hypertension. It was a pilot site so she has collected data to help support and justify additional programs. Bryan mentioned that there are other clinics in the Advocate system, but it all depends on resources available and most need.
- Chris Quillian mentioned she has her own heart failure clinic now where before she was working in conjunction with a Nurse Practitioner. Patients are stabilized at an extender clinic and then referred to her for chronic management. She will be working with a Cardiology attending and his fellows.

HOT TOPICS

Amazon Drug Distribution Discussion

- Abby mentioned that Amazon is now getting into the drug distribution business.
- Some felt that they are providing a needed service for patients and that pharmacists need to determine what their role is in this process to provide face-to-face counseling with patients.
- Amazon has already advertised for pharmacist positions to perform MTM.
- We will need to identify any possible failures in their model and see how we as pharmacists can change that.

Increasing Drug Costs

- Abby mentioned that though the Administration is trying to get the pharmaceutical industry to lower drug prices, they are instead going up.
- Pfizer just increased the costs of 100 drugs, so perhaps we need to change the incentives to pharma to decrease costs.
- Mary Ann mentioned there have been discussions at Pharmacy Quality Alliance about a value-based purchasing model. Is it possible to devise measures to evaluate a drug to determine if you get your money's worth by using it. The challenge is that Pharma is a member of PQA, so there is some conflict of interest.
