- National Immunization Awareness Month: August
- September 6th- Lisle, IL received a grant to provide an opportunity to get immunization certification for \$99 (Ask Starlin for more info); APhA Home study, complete at home training (online), and then come to live 8 hour session; readdresses proper technique
- Shingrix—Shortage, waiting list for patients; Brandon spoke with GSK rep recommends ordering individual packages instead of 10 pack. A more efficacious vaccine, harder to bill Medicare in clinics so patients should go to the community pharmacy; commercial insurers have 80-90% coverage within clinics; This IM injection may be more painful and patients are not willing to come back for the second dose; book the second injection while the patient is in the clinic
